DISTINCTION TO ACADEMIC

Professor Brian D.O. Anderson, Foundation Professor of Electrical Engineering, has been elected a Fellow of the Australian Academy of Science.

The Vice-Chancellor stated that Professor Anderson's election was a great personal honour as well as an honour for the university, which had not previously had a member of staff elected to Fellowship of the Academy of Science.

Professor Anderson, an Australian, much of whose career has been spent in the United States, joins a distinguished body which was constituted by Royal Charter in 1954 and which incorporates about 150 persons who are eminent in various fields of scientific endeavour.

Professor Anderson's most important work has been his studies of control and communications systems and network theory. He is a double first-class honours graduate in Science and in Engineering in the University of Sydney and obtained the University Medal in each Faculty. He holds a Ph.D. in Stanford University, to which he was attached as an Assistant Professor in Electrical Engineering prior to his appointment to the first Chair in Electrical Engineering at the University of Newcastle in 1967. He was a Flight Lieutenant in the R.A.A.F. up to 1970. He has been a member of the University Council and is currently a member of the Australian Research Grants Committee.

Among other things, the Australian Academy of Science exists to promote and disseminate scientific knowledge, to maintain standards of scientific endeavour and achievement in the natural sciences, to establish and maintain relations between Australian scientists and international scientific groups, to publish scientific knowledge and to arrange for visits of scientists from other countries to Australia.

Professor Anderson stated that he has been extremely fortunate in the level of support he has received for his research from the University of Newcastle and to have had the benefit of collaboration with a fine group of colleagues. His selection had been due, in no small part, to these factors, together with the experience gained as a result of his trips to the United States.

PROFESSOR DUTTON ELECTED WARDEN

Professor Ken Dutton was elected Warden of Convocation at the annual meeting on 9th May. Professor Dutton, who is Dean of the Faculty of Arts and Professor of French, will hold office for a term of two years and succeeds Mr. Warren Derkenne, a Newcastle solicitor and Member of the University Council, who had been Warden since 1971.

An election to fill vacancies on the Standing Committee resulted in Dr. F.J. Purdue, Mr. G. Mitchell, Miss K. Heiner, Mrs. B. Lord, Mrs. N. Cornelius and Mr. J. Lambert being elected.

At the last meeting of the Standing Committee Mr. J.P. Talty, who was attending his last meeting before retiring on 9th May, was thanked for the outstanding service he has given. He was Warden from 1969 to 1971 and President of the Australian University Graduate Conference in 1973.

PLAN TO RECOGNISE V.C.,'S SERVICE

Standing Committee of Convocation has launched a fund to purchase a special collection of rare books for the University Library to be known as the Auchmuty Special Collection.

The Warden (Professor K.R. Dutton) said the collection was an appropriate way for Convocation to acknowledge the outstanding service given to Newcastle University College, and its successor, the University of Newcastle, by the Vice-Chancellor over 21 years.

Professor Auchmuty will retire on 31st December, and, since he is an Historian, the collection of books will be chosen from specialised Historical volumes. An invitation has been issued by Standing Committee for contributions to assist it to establish the book collection.

MATHS CONFERENCE AT UNIVERSITY

The Australian Mathematical Society will stage its 18th annual meeting and conference at the University of Newcastle from 27th to 31st May. Approximately 170 members are expected to attend and 60 papers will be discussed.

Most of the visitors will be accommodated in Edwards Hall. Main sessions of the meeting will be held in the Great Hall of the University. Lunches and evening meals will be provided in the Staff House.

Registration will take place on 27th May, between 9 and 10.30 a.m. in the Special Functions Room of the Great Hall. The visitors will be welcomed to the University at a function in the Staff House at 5.20 p.m. On the Tuesday night, the annual dinner will be held at Edwards Hall.

The annual general meeting of the Australian Mathematical Society will be held in Lecture Theatre BO1 on Thursday at 4.10 p.m.

The Society was formed in 1971 and has chapters in nearly all Australian capital and large provincial cities including the Hunter Valley.

The Australian Society for Operations Research aims to foster the science and application of Operations Research, one definition of which is: "the use of scientific method to provide a quantitative basis for executive decision". A National Conference is held every two years, the next scheduled for Sydney in 1975.

PROFESSOR OF DRAMA

The Vice-Chancellor recently announced the appointment of *Dr. R.J. Jordan*, M.A. (Qld.), Ph.D. (London), at present Reader in the Department of English at the University of Queensland, to the newly established Chair of Drama at the University.

The Vice-Chancellor said Professor Jordan had been appointed subject to him satisfying the University's medical requirements.

Dr. Jordan originally graduated with First Class Honours and the University Medal at the University of Queensland and after taking his M.A. degree at Queensland University proceeded to a Ph.D. at the University of London. He joined the staff of the University of Queensland as a Lecturer in English in 1965, was promoted to Senior Lecturer in 1967 and has been a Reader since 1973. All of his teaching has been within the Department of English and has been exclusively in the field of Drama and over the past two years has been primarily in units specifically set up as undergraduate courses in Drama and Theatre. He has supervised a number of postgraduate theses in the field of Drama and has published a number of papers, all of them in overseas journals and, in conjunction with Dr. H.H.R. Love, of Monash, he is currently preparing an edition of the works of Thomas Southerne for publication by the Clarendon Press, Oxford. He is also completing a book on Restoration Comedy. Although not himself at any time a professional actor, a number of his students have subsequently gone into the professional theatre where the preparation given by his course has received wide recognition.

Dr. Jordan is 39 years of age, married with two children.

PROFESSOR HEADS NEW BOARD

Professor L.N. Short, of the Department of Education, has assumed office as Chairman of the New South Wales Board of Adult Education. Dr. P. Kirton, a member of the University Council, is also a member of the Board.

The Minister for Education (Mr. Willis) said the establishment of the board marked the beginning of a new era in education in N.S.W. It replaced the Adult Education Advisory Board, which made recommendations on the distribution of funds.

CONFIRMATION OF ENROLMENT

In the past, students have complained at having to lodge an Application to Sit for Examinations. This year a new system is being introduced which, it is hoped, students will find more convenient but which will still provide the accurate enrolment information which is essential to the organisation of examinations. ELECTION OF MEMBERSOF THE COUNCIL

Notice is hereby given that pursuant to subsection (6) of section 10 of the University of Newcastle Act, 1964-70, an election will be held on 26th June, 1974 and 27th June, 1974 for the purpose of electing to the Council of the University two students of the University.

One person elected shall fill the normal vacancy occurring on 1st July, 1974 and shall hold office until 30th June, 1976. The other person elected shall fill the casual vacancy caused by Gregory Paul Giles ceasing to be a member of Council because he ceased to be a student of the University and shall hold office for the remainder of his term of office, namely until 30th June, 1975.

NOMINATIONS

Nominations of persons eligible for election are hereby invited.

Nominations shall be made by delivering nomination papers to the Returning Officer (Secretary to the University, Room 174, Main Building) NO LATER THAN 12 NOON ON WEDNESDAY, 12TH JUNE, 1974.

A nomination paper shall be signed by two persons entitled to vote at the election for which the candidate is nominated, shall be endorsed with or accompanied by the written consent of the candidate to his nomination, and shall specify the class of vacancy for which the candidate is nominated and the qualifications of the candidate and his nominators.

There shall be a separate nomination paper for each candidate.

ELIGIBILITY

The attention of potential candidates is drawn to the provisions of subsections (6) and (10) of section 10; and of section 11 of the Act, namely -

"10 (6) Two members shall be elected in the manner provided by the By-laws by the students of the University:

> Provided that a person who is not a student of the University shall be ineligible to be elected as a member under this subsection:

For the purposes of this subsection "student" means a person who is enrolled as a candidate proceeding to a degree or diploma at the University."

- "10 (10) A person who is a full-time member of the staff of the University shall be ineligible to be a member appointed or elected in terms of subsections six, seven and nine of this section."
- "11 No person who -
 - (a) (deleted 1970);
 - (b) is an undischarged bankrupt, or has his affairs under liquidation by arrangement with his creditors;
 - (c) has been convicted of an offence and sentenced to imprisonment, unless he has received a free pardon or has undergone the sentence; or
 - (d) is a mentally ill person, a protected person or an incapable person within the meaning of the Mental Health Act, 1958, as amended by subsequent Acts,

shall be capable of being or continuing to be a member of the Council."

In addition to indicating his consent to his nomination, in accordance with the requirement set out above, a candidate is requested to declare that he

is eligible for election within the provisions of subsections (6) and (10) of section 10 and of section 11 of the Act.

PUBLICATION OF NAMES OF PERSONS NOMINATED

The names of persons nominated will be published on the Notice Board at the head of the main stairway in the Main Building on Thursday, 15th June, 1974.

VOTING

In the event of more than one valid nomination being received, a secret ballot will be conducted by means of personal voting.

ALL STUDENTS OF THE UNIVERSITY ARE ENTITLED TO VOTE

A student of the University for this purpose is defined as a person who is enrolled as a candidate proceeding to a degree or diploma at the University.

Votes will be taken in the foyer of the University Library between the hours of 11.30 a.m. and 2.30 p.m. and 5.30 p.m. and 7.30 p.m. on Wednesday, 26th June, 1974 and Thursday, 27th June, 1974.
